

# **NOMINATIONS ARE SOUGHT EFFECTIVE IMMEDIATELY FOR THE: WOMAN OF THE YEAR AWARD**

## **Purpose and Philosophy**

The purpose of this annual award is to recognize and honor outstanding leaders at Seton Hall University who have made significant contributions to the success of women at the University. This award does more than honor an individual. It spotlights the accomplishments of women on the SHU campus and thereby increases the pride of women within the SHU community.

## **Criteria for Selection**

In making the final selection for an award under the program the following criteria are used:  
The recipient shall:

1. Have attained prominence through efforts to advocate women issues and activities at SHU.
2. Be a person of such integrity, stature and demonstrated ability that the Students, Faculty, Staff, and Administrators at SHU take pride in and are inspired by this recognition.
3. By deeds and actions, reflect the importance of women at SHU and loyalty to women's issues at SHU.
4. Be eminently successful on campus and in the community, with a record of accomplishments that is impressive to the SHU community.

## **Eligibility**

The recipient must be a person who is in good standing with the University.

The recipient must be active in women's issues at SHU and is seen as a leader by the SHU community.

## **Method of Selection**

1. Nomination may be made for Woman of the Year by any individual or group at SHU.
2. Nominations are due by March 16, 2007.
3. No limitation is placed on the number of nominations to be submitted for consideration, however, only one nomination is necessary for an individual nominee to be considered, and the identity of the nominator will not be disclosed to the selection committee.
4. A standard nomination form will be provided for all nominations.
